to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Garold D. Sloan and his heirs and assigns forever:

All that certain parcel or lot of land containing 5.80 acres, more or less, situated on the east side of the county road leading from Berry's Mill to Pleasant Hill Church, near Berry's Mill, Highland Township, Greenville County, State of South Carolina, and being Lot No. 7 of the property of Austin and Maye W. Greene, according to survey and plat by H.S. Brockman, Registered Surveyor, dated July 23, 1955, and having the following courses and distances, to-wit:
