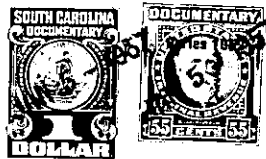

ALL that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, South Carolina, being known and designated as Lot 89 as shown on plat of Pine Brook Development made by W. N. Willis, Engineer, on March 27, 1951, recorded in the R.M.C. Office for Greenville County in Plat Book "Z", at page 148, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at joint corner of lot 89 with power transmission line right-of-way, same being on the Western side of Brewster Drive, and running thence along power transmission line right-of-way, S.73-06 W. 291 feet to an iron pin in line of Pinehurst Development; thence along line of Pinehurst Development, N.61-20 E. 119.5 feet to an iron pin; thence N.64-05 E. 159.5 feet to an iron pin on Western side of Brewster Drive; thence along Brewster Drive, S.13-35 E. 53.8 feet to an iron pin, the point of the beginning.

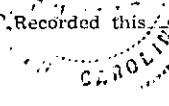
