to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said S. RUSSELL STOVER, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 20, according to Plat of Section I of Lake Forest, which plat is recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "GG", page 17, and having, according to said plat, the following metes and bounds, to wit:-

BEGINNING at an iron pin on the Westerly side of Lake Fairfield Drive, joint front corner Lots 19 and 20, and running thence S. 74-02 W. 183.1 feet to an iron pin, joint rear corner Lots 19 and 20; thence N. 7-44 W. 137.8 feet to an iron pin; thence N. 84-40 E. 150 feet to an iron pin on Lake Fairfield Drive; thence along Lake Fairfield Drive S. 24-32 E. 110 feet to an iron pin, the point of beginning.

The above described property is conveyed subject to certain recorded and existing building restrictions, easements and rights of way.
