to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

Dempsey Parker, his Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, about two miles northwest from Greer, S. C., lying south from Tyger River and on the south side of the 850 elevation water right line of the Reservoir of the City of Greer, S. C., and being a part of the an 40.52 acre tract of land conveyed to me by deed from J. R. Pollard, and being shown and designated as lot No. 8 on plat of property of L. E. Pollard made by H. S. Brockman, Surveyor, December 14th 1956, and having the following courses and distances, to wit:-

Beginning on an iron pin on the said 850 elevation water right line, joint corner of lots Nos. 7 and 8 and runs thence with the said 850 elevation line, S. 81-20 E. 140 feet to a stake; thence continuing with the said 850 elevation line, S. 64-30 E. 108 feet to an iron pin, joint corner of lots Nos. 8 and 9; thence with the common line of lots 8 and 9, S. 31-04 W. 186 feet to an iron pin, joint corner of lots 8 and 9; thence N. 77-20 W. 163 feet to an iron pin, joint corner of lots Nos. 7 and 8; thence with the common line of lots Nos. 7 and 8, N. 5-50 E. 192 feet to the beginning corner, containing Ninety One One-hundredths (0.91) of one acre, more or less.
