Hyman Lurey, his heirs and assigns forever:

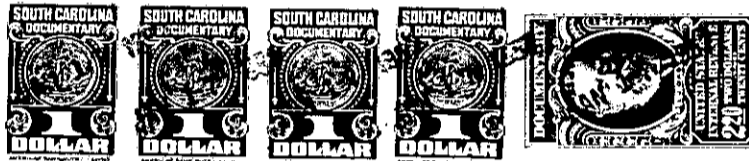

BEGINNING at an iron pin on the westerly side of Bedford Drive at a point 275 feet south of the southwesterly corner of the intersection of Bedford Drive and East Heathwood Drive, said pin being the joint front corner of Lots Nos. 38 and 39, and running thence along the joint line of said lots N 80-06 W 200 feet to an iron pin; thence S 9-54 W 200 feet to an iron pin, joint rear corner of Lots Nos. 36 and 37; thence along the joint line of said Lots S 80-06 E 200 feet to an iron pin on the westerly side of Bedford Drive; thence along the westerly side of said Drive N 9-54 E 200 feet to the point of beginning.
