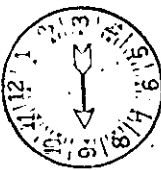

All that piece, parcel or lot of land located in Gantt Township, Greenville County, in subdivision off White Horse Road known as White Horse Addition according to plat made by J. C. Hill, May 15, 1951 recorded in R. M. C. Office for Greenville County in Book "W" page 187, said lot being # 10 on Evelyn Drive, and being more particularly described as follows:

BEGINNING at an iron pin at the West Side of Evelyn Drive, at corner with Spears Drive, thence S. 30-45 E. 67 feet along said Evelyn Drive to an iron pin which is the joint corner of lots 10 and 9; thence S. 76-20 W. 200 feet along joint line of these two lots to an iron pin; thence N. 30-45 W. 69.4 feet to an iron pin on Spears Drive; thence along Spears Drive N. 77-E. 200 feet to an iron pin on Evelyn Drive, the point of beginning.

No residence is to cost less than \$4000.00 and no residence shall be erected on said lot nearer than 50 feet to the front line.

No outside toilets are permitted and sewage is to be disposed of by approved septic tanks.
