This deed is made subject to any rights of way which may have previously been given. Said lands shall not be sold, rented or otherwise disposed to any person of African descent. No residence shall be erected at a cost less than \$3000.00; nor nearer than 25 feet to the front line; nor shall any residence be erected on any lot unless said lot have 50 feet frontage or more. No outside toilets are permitted and sewage must be disposed of by approved septic tank.

Grantee herein to pay taxes for the year 1957.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining
