That HUGUENIN & DOUGLAS INC., a corporation in the State aforesaid, in consideration of the sum of ONE THOUSAND THREE HUNDRED FORTY FIVE & 50/100 DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WILLIAM L. COSTNER, his heirs and assigns forever

All that piece, parcel and lot of land in Gantt Township, Greenville County, State of South Carolina, near the City of Greenville being known as Lot No. 28 according to a survey of Belle Meade Subdivision made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book EE, Pages 116-117. Said lot fronts on Brookforest Drive and is more particularly described as follows:

BEGINNING at an iron pin on the west side of Brookforest Drive at the joint front corner of Lots 28 and 29 and running along the common line of Lots 28 and 29 S. 69-44 W. 150.5 feet to an iron pin, joint rear corner of Lots 29 and 29; thence N. 19-0 W. 75.05 feet to an iron pin, joint rear corner of Lots 27 and 28; thence along the common line of Lots 27 and 28 N. 69-44 E. 148.6 feet to an iron pin on Brookforest Drive, joint front corner of lots 27 and 28; thence along Brookforest Drive S. 20-16 E. 75 feet to an iron pin, the beginning corner.

Subject, however, to those protective covenants and restrictions, and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 505, at Page 73, Deed Book 511, at Page 513 and Deed Book 521 at Page 199.

The grantee is to pay 1957 taxes.

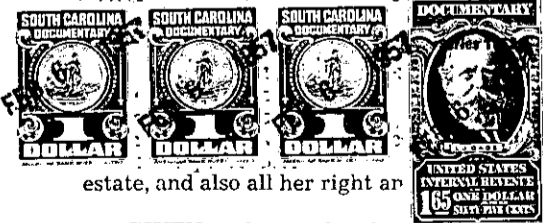
