Haskell & Robinson, Inc., its successors and assigns forever:

All that certain piece, parcel or lot of land lying and being on the northwesterly side of Selwyn Drive, near the City of Greenville, S. C., being shown as Lot No. 6 on the plat of Timberlake as recorded in the RMC Office for Greenville County, S. C. in Plat Book BB, page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Selwyn Drive, said pin being the joint front corner of Lots Nos. 5 and 6, and running thence along the joint line of said Lots N 21-39 W 180 feet to an iron pin; thence S 68-21 W 105.3 feet to an iron pin, joint rear corner of Lots Nos. 6 and 7; thence along the joint line of said Lots S 26-23 E 185 feet to an iron pin on the northwesterly side of Selwyn Drive; thence along the northwesterly side of said Drive N 64-16 E 55 feet to a concrete monument; thence continuing along the northwesterly side of said Drive N 68-21 E 35 feet to the point of beginning.
