Know All Men by These Presents:

That I, M. W. Fore in the State aforesaid,
in consideration of the sum of Five Hundred & NO/100 - - - (\$500.00) - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. M. Forester and Lucille Forester, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, in Gantt Township, being known and designated as Lot No. 1, as shown on plat of Brookwood, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 27, and being more particularly described according to said plat as follows.

BEGINNING at an iron pin in the Western side of Fairfield Road, at the joint front corner of Lots Nos. 1 and 2, and running thence with the joint line of said lots, N. 86-54 W. 221 feet to an iron pin in line of lot 121; thence with line of said lot, N. 3-30 E. 91.5 feet to an iron pin; thence S. 86-56 E. 250 feet to an iron pin in the Western side of Fairfield Road; thence with said Road, S. 20-39 W. 95.8 feet to the point of beginning.

THAT the said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent; no residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on said lots; no residence shall be erected on any lot nearer than thirty-five (35) feet to the front line; no residence shall be erected on any lot unless said lot has fifty (50) feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.

GRANTEE to pay taxes for the year 1957.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

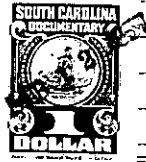
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and their Heirs and Assigns forever.
