All that piece, parcel and lot of land in Gantt Township, Greenville County, State of South Carolina, near the City of Greenville, being known as Lot No. 160 Pine Creek Drive according to a survey of Belle Meade Subdivision(Section 3)made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "GG" at Page 187, and being more particularly described as follows:

BEGINNING at an iron pin on the south side of Pine Creek Drive at the joint front corner of Lots 159 and 160 and running along the line of Lot 159 S. 14-50 W. 150 feet to an iron pin, joint rear corner of Lots 159 and 160; thence N. 75-10 W. 90 feet to an iron pin, Joint rear corner of Lots 160 and 219; thence along the line of Lot 219 N. 14-50 E. 150 feet to an iron pin on Pine Creek Drive, thence along Pine Creek Drive S. 75-10 E. 90 feet to an iron pin, the beginning corner.
