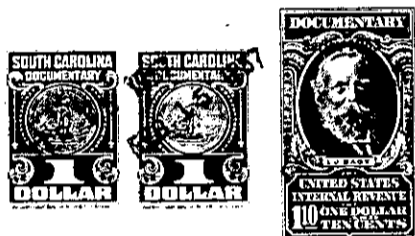
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Henry C. Harding, his heirs and assigns forever, all that piece, parcel or lot of land in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 16, as shown on plat of property belonging to Lela S. Hodgens, said plat made by J. Coke Smith and Son, April 24, 1956, recorded in the R. M. C. office for Greenville County, South Carolina, in Plat Book JJ, at page 189, and being more particularly described according to said plat as follows:

Beginning at an iron pin on the right of way of Hodgens Drive and running thence along line of Lot No. 18, S33-37 E, 135.7 feet to an iron pin at the rear joint corner of Lots Nos. 17, 18 and 19; thence along rear line of lot No. 17, N. 54-54 E. 85 feet to an iron pin at the rear joint corner of Lots Nos. 14, 15 and 17; thence N. 33-37W. 138.2 feet along line of Lot No. 14; thence along right of way of Hodgens Drive S. 54-54 W. 85 feet to the beginning corner.

This lot of land is sold subject to the restrictions and covenants which are entered on the record in the R. M. C. office for Greenville County of South Carolina, in Deed Book 551 and at page 131, and which shall be binding upon the Grantee herein.
