Morris, her heirs and assigns forever:

ALL that piece, parcel or lot of land near the City of Greenville, State of South Carolina, being known and designated as Lots Nos. 81, 81-A, 82 and 82-A, of a subdivision known as Bellwood Estates Section 2, dated 1955 by Woodward Engineering division known as Bellwood Estates Section 2.
