C., its successors and assigns:

All that piece, parcel or tract of land situate, lying and being in Saluda Township, in Greenville County, State of South Carolina, on Mill Greek waters of North Saluda River, containing 8.41 acres, more or less, and being known as the lill Tract and Lot No. 13, on a plat prepared by Justice & Miller, dated June, 1936, and having the following description:

BEGIXEING at an iron pipe at the intersection of the Old Buncombe Road leading through Wildwood Park and the Hogback Mountain Road leading up the North Saluda Valley, and running thence along the center of said Hoghack Mountain Road, 536 feet to a stake in the center of the said Road on T. E. Edwards line; thence N. 59 %., 500 feet to the center of the North Saluda River; thence down the center of the North Saluda River, 667 feet to the center of the Road opposite a Sycamore tree; thence N. 86-30 ... 200 feet to a stake on the East side of National Firhway No. 25; thence along and up said Highway (also known as Funcombe Road) 810 feet to the intersection of Highway and the Old Buncombe Road leading through Mildwood Park; thence N. 15-30 ..., along the center of said Road and over the rock bridge, 150 feet to the point and place of beginning.
