to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Joe J. Faress, his heirs and assigns, forever.

All that piece, parcel and lot of land in Gantt Township, Greenville County, State of South Carolina, near the City of Greenville, being known as Lot No. 246 Pine Creek Drive according to a survey of Belle Meade Subdivision(Section 3) made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "GG" at Page 187 and being more particularly described as follows:

BEGINNING at an iron pin on the west side of Pine Creek Drive, the joint front corner of Lots 245 and 246 and running along Pine Creek Drive N. 32-08 E. 80 feet to an iron pin, joint front corner of Lots 246 and 247; thence N. 57-52 W. 135 feet to an iron pin, joint rear corner of Lots 246 and 247; thence S. 32-08 W. 80 feet to an iron pin, joint rear corner of Lots 245 and 246; thence S. 57-52 E. 135 feet to an iron pin on Pine Creek Drive, the beginning corner.

Subject, however, to those protective covenants and restrictions, and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 552, at Page 473.

The grantee is to pay 1957 taxes.

Being the same property conveyed to the grantor herein by deed recorded in the R. M. C. Office for Greenville County S. C. in Vol. 571, Page 241.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

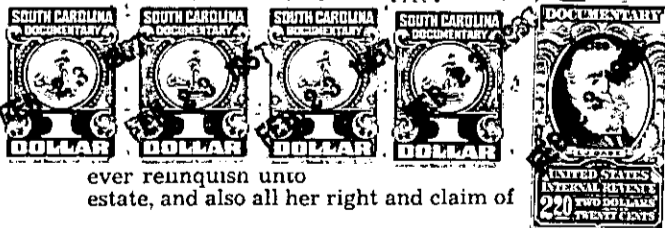
