to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Lloyd C. Allen, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina being known and designated as Lot No. 60 of Pecan Terrace, Section 2 as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "EE", Page 108 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of N. Wingate Road at the joint front corner of Lots Nos. 60 and 61 and running thence along the joint line of said lots N. 39-0 W. 205 feet to an iron pin in branch; thence up the branch as the line, the chord of which is N. 60-44 W. 141.6 feet to an iron pin at the joint rear corner of Lots Nos. 59 and 60; thence along the joint line of said lots S. 19-23 E. 207 feet to an iron pin on the northern side of N. Wingate Road; thence along the northern side of N. Wingate Road and following the curvature thereof S. 61-22 W. 70 feet to the beginning corner.

This lot is conveyed subject to restrictions recorded in the R. M. C. Office for Greenville County in Deed Book 541, at Page 425.
