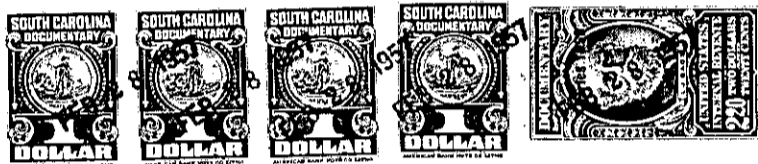
Know All Men by These Presents: OLLIE F. SWORTH R.M.C.

CHANDLER in the State aforesaid, in consideration of the sum of ONE THOUSAND EIGHT HUNDRED FORTY-FIVE AND NO/100---DOLLARS, (\$1,845.00) to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JAMES C. BALENTINE, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 100 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Eastern side of McSwain Drive at the joint front corner of Lots 99 and 100 and running thence N 67-37 E 174.9 feet to a point at the joint rear corner of Lots 99 and 100; thence S 22-19 E 87 feet to a point at the joint rear corner of Lots 100 and 101; thence S 67-37 W 174.9 feet, more or less, to a point on the Eastern side of McSwain Drive at the joint front corner of Lots 100 and 101; thence with the Eastern side of McSwain Drive N 22-23 W 87 feet to the point of beginning.
