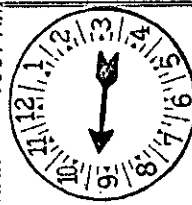

WHEREAS, Riegel Textile Corporation conveyed unto Fork Shoals Mill Baptist Church the property described more fully below by deed dated September 25, 1953, recorded in Book 505 at Page 234 in the Office of the Register of Mesne Conveyances for Greenville County and by corrective deed dated _____, 19____, recorded in Book _____ at Page _____ in the Office of the Register of Mesne Conveyances for Greenville County; and

WHEREAS, said deeds contain a reservation whereby said property would revert to Riegel Textile Corporation should the same ever cease to be used as a place of worship; and

WHEREAS, said lot has now ceased to be used as a place of worship and Fork Shoals Mill Baptist Church desires to recognize said fact and to relinquish any interest it may have in said property,

NOW, THEREFORE,

KNOW ALL MEN BY THESE PRESENTS, That Fork Shoals Mill Baptist Church by

its Deacons and

its Pastor, of the County of Greenville

in the State aforesaid for and in consideration of the sum of One and no/100 (\$1.00) Dollars to it in hand paid at and before the sealing of these presents, by Riegel Textile Corporation, of the County of Greenwood in the State aforesaid

the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Riegel Textile Corporation:

All that piece, parcel or tract of land, situate, lying and being in Fork Shoals, Greenville County, South Carolina, and being located just off Cedar Falls Road, which lot is shown as lot No. 20 on a plat entitled Subdivision of the Residential Properties of Fork Shoals, South Carolina of Riegel Textile Corporation, located in Greenville County, Fork Shoals, South Carolina. According to said plat, the metes and bounds of said lot are as follows: Beginning at a point located north 80° 08' east at a distance of 164.8 feet, more or less, from the northwestern corner of lot No. 19 as shown on said plat, which said northwestern corner is located on the edge of Cedar Falls Road, thence north 35° 43' east for a distance of 78.2 feet, more or less, to a corner; thence north 57° 50' east for a distance of 84 feet, more or less, to a corner; thence south 52° 58' east for a distance of 72.2 feet, more or less, to a corner; thence south 16° 41' east for a distance of 119.5 feet, more or less, to a corner; thence south 67° 55' west for a distance of 180 feet, more or less, to a corner; thence north 22° 05' west for a distance of 87 feet, more or less, to a corner; thence north 14° 05' west for a distance of 37.9 feet, more or less, to the point of beginning.

The plat above referred to is recorded in the Office of the Register of Mesne Conveyances for Greenville County in Plat Book BB at Pages 156 and 157.
