All that lot of land in the County of Greenville, State of South Carolina, designated as Lot No. 15, Block "C", as shown on a revised plat of a portion of Block "C" of BROOKFOREST subdivision by Dalton & Neves, November 1956, recorded in Plat Book LL page 188 of the R.M.C. Office for Greenville County, S. C. and having according to said plat and a recent survey by A. ... Dalton, February 1957, the following metes and bounds, courses and distances, to wit:

BEGINNING at an iron pin on the southerly side of Westbrook Lane, the front joint corner of Lots Nos. 15 and 16; thence with the joint line of said lots, S. 22-02 W. 140 feet to an iron pin, corner of Lot No. 17; thence with the rear line of said Lot, S. 5-31 E. 37.9 feet to an iron pin, corner of Lot No. 19; thence with the line of said lot, S. 54-05 E. 2 feet to an iron pin, corner of Lot No. 14; thence with the line of said lot, N. 31-58 E. 17 feet to an iron pin on the southerly side of Westbrook Lane; thence with the said southerly side of said Westbrook Lane, N. 71-13 W. 85 feet to the beginning corner.

The above described lot is the major portion of Lot No. 15 as shown on plat of BROOKFOREST, recorded in Plat Book LL page 41 of the R.M.C.
