

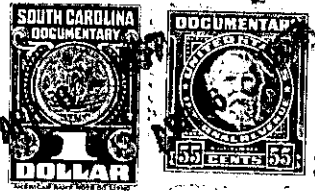

County, State of South Carolina Situate west and south-west of lands presently  
owned by C. Paul Manly, the same having the following metes and bounds  
according to a plat made by J. C. Hill, Surveyor, on Feb. 28, 1956:

Beginning at an iron pin, the same being, the present joint corner  
of lands now owned by the grantor and the grantee, and running thence along  
the line of the lands of the grantor and the grantee N. 59-W. 180 feet to  
an iron pin at the joint corner of lands of the grantor and grantee; thence  
along the present line of the lands of the grantor and the grantee N. 27-12 E.  
239 feet to an iron pin at the joint corner of the lands of the grantor and  
the grantee; Thence S. 85-W. 65 feet to an iron pin; thence S. 27-12 W. 183  
feet to an iron pin; thence S. 33-45 E. 263.8 feet to an iron pin on the
