In consideration of the sum of \$10.00 in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JOHN G. ROZAKOS and GEORGE ROZAKOS, their heirs and assigns forever,

ALL that piece, parcel or lot of land situate, lying and being in Ward 5 of the City of Greenville, being known and designated as Lot No. 7 Block 3, page 82 of the City Block Book and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the East side of Anderson Street, corner of lot now or formerly owned by S. C. Calder, said point being 84.75 feet from the Southeast intersection of Anderson Street and St. John Street; and running thence in a Southwesterly direction along the East side of Anderson Street, 84.75 feet to the corner of lot now or formerly owned by Rueben Gosnell; thence with the line of said lot, S. 79 E. 165.75 feet to an iron pin; thence N. 12 E. 84.8 feet to the corner of Calder lot; thence with the line of said lot, N. 79 W. 168 feet to the beginning.

Being the same property conveyed to Robert Lee Rollins by R. P. and Juanita F. Porter by deed dated Sept. 15, 1953 and recorded in Deed Book 485, at page 531, RMC Office for Greenville County.

The above Grantor, along with Marian Jeannette Crabtree, Kenneth L. Rollins, Richard D. Rollins, Betty R. Thompson, Vernon A. Rollins, Cecil H. Rollins and Mamie Eunice Leach Rollins constitute all the children and the widow of R.L. Rollins, who died testate in Greenville, S.C. on May 6, 1953. Mamie Eunice Leach Rollins was appointed Executrix with full power of sale. Said Will provided that in the event it became necessary, the real estate should be sold if the other income of Mamie Eunice Leach Rollins was insufficient to maintain her in the same status which the deceased had supported her during his lifetime. The undersigned son joins in the other deed of said children and consents that said real estate be sold.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
