KNOW ALL MEN BY THESE PRESENTS, That I, NELSON JACKSON, II,.....

in the State aforesaid, in consideration of the sum of One Thousand Five Hundred Fifty and No/100----- Dollars

to me in hand paid at and before the sealing of these presents by THE CITY OF GREENVILLE, SOUTH CAROLINA,.....

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said THE CITY OF GREENVILLE, SOUTH CAROLINA, its successors and assigns, forever:

ALL that piece, parcel or lot of land, situate, lying and being in Glassy Mountain Township, Greenville County, State of South Carolina, being composed of several lots in Blue Ridge Forest, shown on plat of property of Carolina Mountains, Inc., being more particularly described as follows:

LOT 5, Section "K", begins at an iron pin in the Northern edge of Hogback Circle at corner of Lot 4 and runs thence in a Westerly direction along the Northern edge of said Hogback Circle, 140 feet to an iron pin; thence N. 9-46 E., 236.5 feet to an iron pin; thence N. 87-30 E., 50 feet to an iron pin; thence S. 12-03 E., 233.7 feet to an iron pin at the beginning corner, and being the same property conveyed to Nelson Jackson, II, by deed of the Forfeited Land Commission, dated October 21, 1953, recorded in the RMC Office for Greenville County, S. C., in Deed Book 487, page 388.

ALSO LOT 13, Section "M", begins at an iron pin at the intersection of Piedmont and Pacolet Drive; thence with Pacolet Drive, N. 73-27 W., 165 feet to an iron pin; thence S. 21 W., 128.5 feet to an iron pin; thence N. 84 E., 175 feet to an iron pin; thence with Piedmont Drive, N. 13-22 W., 65 feet to an iron pin at the beginning corner, and being the same property conveyed to Nelson Jackson, II, by deed of the Forfeited Land Commission, dated October 21, 1953, recorded in said RMC Office in Deed Book 487, page 393.

ALSO LOT 28, Section "J", begins at an iron pin on the Northwestern edge of Piedmont Drive at corner of Lot 27; thence in a Northern direction along the Western edge of Piedmont Drive, 340.2 feet to an iron pin; thence S. 0-05 W., 198.5 feet to an iron pin at the beginning corner, and being the same property conveyed to Nelson Jackson, II, by deed of the Forfeited Land Commission, dated October 21, 1953, recorded in said RMC Office in Deed Book 487, at page 394.

ALSO LOT 25 and 1/2 LOT 29, Section "J", begins at an iron pin on the Northwestern edge of Piedmont Drive at corner of Lot 30; thence in a Northeastern direction along the Northwestern edge of Piedmont Drive, 67.5 feet to an iron pin; thence N. 42-21 W., 164.8 feet to an iron pin; thence N. 2-30 W., 165 feet to an iron pin; thence in a Southwestern direction along the Southwestern edge of Piedmont Drive, 100 feet to an iron pin; thence S. 0-13 E., 240 feet to an iron pin; thence S. 66-29 E., 200 feet to an iron pin
