Kenneth M. Williams and Alwayne D. Williams, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina on the western side of Biltmore Avenue being known and designated as Lot No. 6 of the property of Roy J. Meadors and having, according to a plat prepared by Piedmont Engineering Service dated July 24, 1954, the following metes and bounds, to-wit:

BEGINNING at a point on the western side of Biltmore Avenue, the joint corner of Lots Nos. 6 and 7 and running thence N. 80-09 W. 232.7 feet to a point; thence N. 10-53 E. 661 feet to a point; thence S. 80-24 E. 235.3 feet to a point on Biltmore Avenue; thence with Biltmore Avenue S. 9-36 W. 64.9 feet to the point of beginning.

This being one of the lots conveyed to the Grantor herein by deed of Mrs. Willie Martin dated July 22, 1954 and recorded in the R. M. C. Office for Greenville County in Deed Book 504 at Page 536.

As a part of the consideration for this conveyance the Grantees expressly assume a mortgage given to First Federal Savings and Loan Association dated September 10, 1954 and recorded in the R. M. C. Office for Greenville County in Mortgage Book 609, Page 240, in the original amount of \$9,000 and having a present balance of \$8,229.92.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

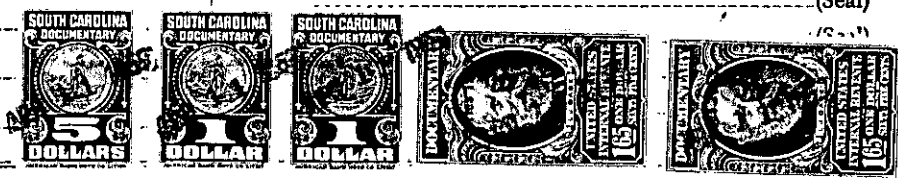
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.
