Know All Men by These Presents:

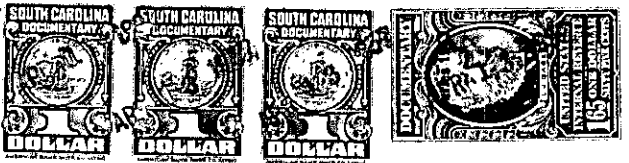

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Herbert C. Wood, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being at the southeast intersection of Edwards Road and an unnamed street, near the City of Greenville, County of Greenville, State of South Carolina and being known and designated as Lot No. 2, Section A, of a subdivision known as Green Forest, plat of which was prepared by Woodward Engineering Co. to be recorded, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Edwards Road at the joint front corner of Lots Nos. 1 and 2, Section A, and running thence along the eastern side of Edwards Road N. 9-57 E. 65 feet to an iron pin at the intersection of Edwards Road and an unnamed street which intersection is curved (the chord of which is N. 30-40 E. 34.4 feet) to an iron pin on the southern side of the unnamed street; running thence along the unnamed street S. 77-08 E. 125 feet to an iron pin; running thence S. 12-08 W. 80 feet to an iron pin at the joint rear corner of Lots Nos. 1 and 2; running thence along the joint line of said lots N. 81-01 W. 145.7 feet to an iron pin, the point of beginning.
