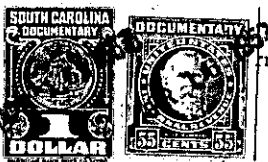

L. A. MOSELEY, his heirs and assigns:

All of my one-half undivided interest in and to all of that piece or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 67, Section 1, on Plat of Fresh Meadow Farms, which plat is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "M", page 127, and also in Plat Book "S", page 61, and having, according to the said plats, and according to a plat of the Property of Robert Fred Lance, Jr., made by R.
