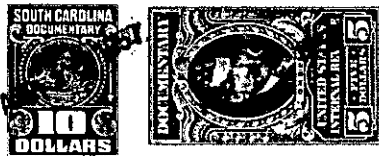

That I, E. D. Sloan, in the State aforesaid, in consideration of the sum of Five Thousand & no/100 (\$5,000.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. Alvin Gilreath, his heirs and assigns, forever:

ALL That piece, parcel or lot of land situate on the western side of Partridge Lane in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 20 on plat of property of E. D. Sloan, prepared by Dalton & Neves, Engineers, dated June, 1955 (with addition made August, 1956) and recorded in the Office of the R.M.C. for Greenville County in Plat Book EE, Page 135, and having according to said plat the following metes and bounds, to-wit:

BEGINNING At an iron pin on the western side of Partridge Lane at the joint front corner of Lots 20 and 21, and running thence along the joint line of said lots, N. 86-06 W. 200.7 feet to an iron pin in the rear line of Lot 19; thence turning and running along a portion of the rear line of Lot 19, S. 6-11 W. 100.1 feet to an iron pin on the north side of Partridge Lane; thence along the north side of Partridge Lane, S. 80-32 E. 175 feet to an iron pin; thence along the curve of Partridge Lane, the chord of which is N. 53-04 E. 34.5 feet to a monument on the western side of Partridge Lane; thence along the western side of Partridge Lane, N. 6-41 E. 95.9 feet to the point of beginning.

This property is subject to restrictions recorded in the office of the R.M.C. for Greenville County in Deed Book 530, Page 487.

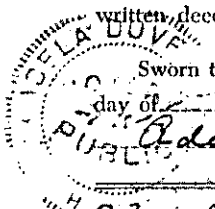
