ALL that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina on the western side of Biltmore Avenue being known and designated as Lot No. 9 of the property of Roy J. Meaders on a plat prepared by Piedmont Engineering Service dated July 24, 1954 and revised September, 1954 and recorded in the R. M. C. Office for Greenville County in Plat Book "NN" at page 5 and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the western side of Biltmore Avenue at the joint front corner of Lots Nos. 8 and 9 and running thence N. 79-12 W. 240.2 feet to a point; thence S. 32-57 E. 91 feet to a point at the joint corner of Lots 9, 10 and 11; thence S. 81-15 E. 190 feet to a point on Biltmore Avenue; thence with Biltmore Avenue N. 2-07 E. 62.8 feet to the point of beginning.

This being one of the lots conveyed to the Grantor herein by deed of Mrs. Willie Martin dated November 12, 1954 and recorded in the R. M. C. Office for Greenville County in Deed Book 512 at age 515.

AS a part of the consideration herein the Grantee expressly assumes a mortgage given to First Federal Savings and Loan Association in the original amount of \$9,000.00 and recorded in the R. M. C. Office for Greenville County in Mortgage Book 617 at Page 299, having a present balance of \$8,227.80

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

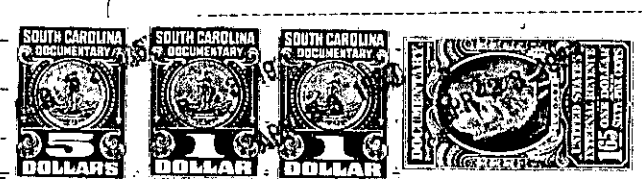
