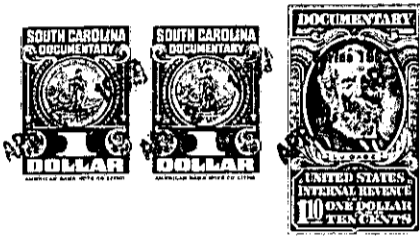
That I, Annie T. Henderson, in the State aforesaid, in consideration of the sum of Five Hundred and Sixty (\$560.00) DOLLARS,
