All of that piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the Westerly side of Welcome Street at the Southwesterly corner of the intersection of Welcome Street and Welcome Road near the City of Greenville, Greenville County, S. C., and being known and designated as Lot No. 9 on a plat of the property of Talmer Cordell made by Dalton & Neves, Engineers, in March, 1950, and recorded in the R. M. C. Office for Greenville County in Plat Book X, at page 179, and according to said plat, described as follows:

BEGINNING at an iron pin at the Southwesterly corner of the intersection of Welcome Street and Welcome Road and running thence along the Southern side of said Welcome Road S. 59-30 W. 166.7 feet to an iron pin, joint rear corner of Lots Nos. 8 and 9; thence along the joint rear line of said lots S. 14-0 E. 32.8 feet to an iron pin; joint corner of Lots Nos. 9 and 10; thence along the line of Lots Nos. 9 and 10 N. 72-27 E. 160.5 feet to an iron pin on the Westerly side of Welcome Street; thence along the Westerly side of Welcome Street N. 14-0 W. 70 feet to the beginning corner.

As part of the consideration for the within conveyance the grantee assumes the mortgage on the above described real estate given by Charlie D. Fuller to C.
