


Highway No. 276, joint corner of Lots Nos. 66 and 67, and running thence N. 64-40 E. 200 feet to a point, said point on the joint corner of Lots Nos. 66 and 67; thence N. 29-30 W. 100 feet to a point, joint rear corner of Lots Nos. 66 and 65; thence S. 64-40 W. 200 feet to a point on the Eastern edge of said U.S. Highway No. 276, joint corner of Lots Nos. 66 and 65; thence along the Eastern Edge of said Highway S. 29-30 E. 100 feet to the beginning corner.

AISO, all that other piece, parcel or lot of land adjoining the above described Lot, the same being shown and designated as Lot No. 67 on the plat hereinabove referred to, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the Eastern edge of U. S. Highway No. 276, joint corner of Lots Nos. 67 and 68, and running thence N. 64-40 E. 200 feet to a point, joint rear corner of Lots Nos. 67 and 68; thence N. 26-00 W. 100 feet to a point, joint rear corner of Lots Nos. 67 and 66; thence S. 64-40 W. 200 feet to a point on the Eastern edge of U. S. Highway No. 276, joint front corner of Lots Nos. 67 and 66; thence along the Eastern edge of said Highway S. 23-30 E. 100 feet to the beginning corner.

AISO, all that other piece, parcel or lot of land adjoining the above described lots, the same being shown and designated as Lot No. 70 on the plat hereinabove referred to, and having, according to said plat, the following metes and bounds, to-wit:
