Know All Men by These Presents:

That I, George F. Townes, as trustee for James B. Arrowood and/ James E. Burger in consideration of the sum of Six Hundred and Twenty-five and no/100 (\$625.00)-----DOLLARS,

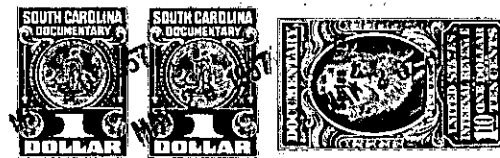
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James E. Burger, his heirs and assigns:

ALL that lot of land in Greenville County South Carolina on the northern side of Jasmine Drive (formerly Douglas Street) being known as Lot #10 of Grand-View as shown on a plat thereof made by Woodward Engineering Company, March, 1957, and having, according to said plat, the following metes and bounds:

BEGINNING at a pin on the northern side of Jasmine Drive at the corner of Lot #9 and running thence with the northern side of Jasmine Drive, N. 72-35 E., 62 feet to a pin at the corner of Lot #11; thence with the line of Lot #11, N. 17-25 W., 150 feet to a pin in the rear line of Lot #23; thence with the rear lines of Lot #23 and #24, S. 72-35 W., 62 feet to a pin in the rear corner of Lot #9; thence with the line of Lot #9, S. 17-25 E., 150 feet to the point of beginning.

This is the same property conveyed to me by Arrowood and Burger by deed recorded in Vol. 573 at page 314 and to them by Eliza T. Looper by deed in Vol. 573 at page 311. This lot is subject to restrictions in Vol. 573 at page 415 and Vol. 574 at page 93.

The grantee owns a one-half beneficial interest in this land, and the expressed consideration is for the remaining one-half interest.
