in consideration of the sum of **Ten Dollars (\$10.00) and other valuable consideration**

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto **J. D. SHERMAN, JR. AND MARGARET C. SHERMAN:**

A one-fourth undivided interest in and to all that piece, parcel or lot of land with the improvements thereon situate, lying and being in the Piedmont Manufacturing Company Village in or near the Town of Piedmont, Greenville County, South Carolina, and being more particularly described as Lot No. 46, Section 3 as shown on a plat entitled "Property of Piedmont Manufacturing Company, Greenville County" made by Dalton & Neves, February, 1950; Sections 3 and 4 of said plat are recorded in the R.M.C. Office for Greenville County in Plat Book Y at pages 2-5, inclusive, and pages 6-9, inclusive, respectively. According to said plat the within described lot is also known as No. 14 Piedmont Street (Avenue) and fronts thereon 90 feet.

This is the identical property conveyed to W. T. Taylor, same as William Terrell Taylor, by deed of Larkin Mayfield, Jr., dated February 10, 1950, and recorded in the R.M.C. Office for Greenville County in Deed Book 428 at page 505. The aforesaid W. T. Taylor, same as William Terrell Taylor, died testate on or about February 22, 1952. See Apartment 611, File 60, Office of the Judge of Probate, Greenville County, S. C. According to the terms of his will, the lot herein conveyed was devised to his widow, Ida S. Taylor, for life, with a one-fourth undivided interest to the grantor herein after her death. Ida S. Taylor died on or about March 16, 1956.
