demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to  
be heard on the 22nd day of May 1957,  
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged  
and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN,  
Master in and for the County aforesaid, to W. D. Ridgeway  
for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County  
of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release  
unto the said W. D. Ridgeway

"All that piece, parcel or lot of land in Dunklin Township, Greenville  
County, South Carolina, having the following metes and bounds:  
BEGINNING at a poplar near Columbia Church Spring and running thence  
S. 45 E. 13.00 chains to a stone 3x (old corner spanish oak down); thence  
N. 24 E. 55.15 chains to creek; thence up the creek to a rock 3x on the  
north bank 60 links below the ford of the branch; thence W. 5.50 chains to  
a rock 3x; thence S. 7 W. 42.20 chains to the beginning corner, and con-  
taining 91 acres, more or less; being the same property conveyed by James  
T. Crane to Anna L. Martin by deed recorded in Vol. FFF at Page 653 and to  
him by Anna L. Martin by deed recorded in Vol. CCC, at Page 387, and to  
her by Allen C. Stepp by deed recorded in Vol. WW, at Page 459."

The purpose of this deed is to correct the description given in a deed  
which is of record in the RMC Office for Greenville County in Deed Book 545,  
Page 135, and is made in accordance with the Decree of Court in this present  
action and is without any monetary consideration. For the foregoing reasons  
it is not necessary to place any revenue stamps on this present deed.
