ALL that lof of land in Greenville County, South Carolina on Jasmine Drive (formerly Douglas Street) known as Lot #9 as shown by a plat thereof made by Woodward Engineering Company, March, 1957 and recorded in the Greenville County R. M. C. Office in Plat Book "KK" at page 93, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern edge of Jasmine Drive at the joint front corner of Lots #8 and #9 and running thence along the northern edge of Jasmine Drive, N. 72-35 E., 62 feet to an iron pin at the corner of Lot #10; thence with the line of Lot #10, N. 17-25 W., 150 feet to an iron pin in the rear line of Lot #24; thence with the rear line of Lots #24 and #25, S. 72-35 W., 62 feet to an iron pin at the rear corner of Lot #8; thence with the line of Lot #8, S. 17-25 E., 150 feet to the point of beginning.
