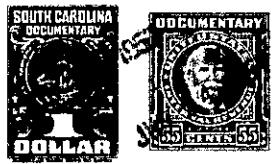

Know All Men by These Presents:

That I, Donavan J. Allen, in the State aforesaid,
in consideration of the sum of Two Hundred Fifty and No/100----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. L. Hallman, Jr., his heirs and assigns forever:

All that certain piece, parcel or tract of land in Greenville County, State of South Carolina situate, lying and being in or near the Town of Piedmont, S. C. and being Tract No. 1 of a resubdivision of Tract No. 516 of Property of J. P. Stevens & Co., Inc., Piedmont, S. C., said original plat being recorded in the R. M. C. Office for Greenville County in Plat Book "KK", Page 61, and the resubdivision showing the subject tract being recorded in the R. M. C. Office for Greenville County in Plat Book "KK", Page 95, and said tract being described according to the last mentioned plat as follows:

BEGINNING at an iron pin on the Saluda River, joint corner with Piedmont Water & Light District and running thence along light district line S. 34-0 E. 772.5 feet to an iron pin in the line of Tract No. 2; thence along the line of Tract No. 2 N. 84-03 W. 65 feet to an iron pin; thence still with Tract No. 2 S. 81-01 W. 95 feet to an iron pin at the joint corner of Tract Nos. 2 and 3; thence along the line of Tract No. 3 S. 78-50 W. 301.6 feet to an iron pin; thence still with Tract No. 3 S. 54-21 W. 142.8 feet to an iron pin at the joint corner of Tracts Nos. 3 and 4; thence along the line of Tract No. 4 S. 67-30 W. 171 feet to an iron pin on the Saluda River; thence up the Saluda River and following the meanderings thereof, the chords of which are N. 12-25 W. 640 feet and N. 34-11 E. 291.6 feet to the beginning corner and containing 6.66 acres, more or less.

The above described property is part of the same conveyed to me by J. P. Stevens & Co., Inc. by deed dated November 7, 1956 and recorded in the R. M. C. Office for Greenville County in Deed Book 566, Page 450.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
