in consideration of the sum of Seven Hundred Thirty-five and No/100----- DOLLARS,

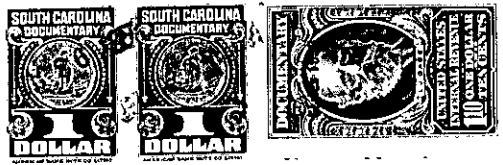
