ALL that lot of land in Greenville County, South Carolina on the southern edge of Crestmore Drive known and designated as Lot #25 on a plat of Grand-View made by Woodward Engineering Company, March, 1957 and recorded in Plat Book "KK" at page 93, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southern edge of Crestmore Drive at the joint front corners of Lots #24 and #25 and running thence along the southern edge of Crestmore Drive, S. 74-17 W., 60 feet to the corner of Lot #26; thence with the line of that lot, S. 15-43 E., 161.4 feet to an iron pin in the rear line of Lot #8; thence with the rear lines of Lots #8 and #9, N. 72-35 E., 60.02 feet to an iron pin at the corner of Lot #24; thence with the line of that lot, N. 15-43 W., 159.6 feet to the point of beginning.
