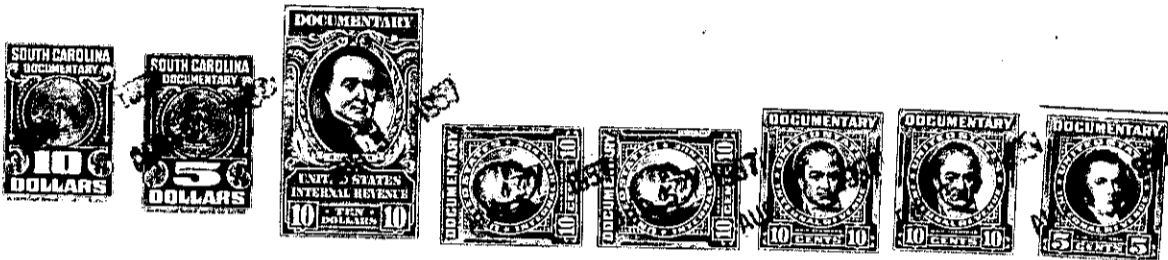
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Denver Mattison and Wilma K. Mattison and their heirs and assigns forever:

All that certain parcel or lot of land situated on the southeast side of the old Greenville - Spartanburg Road near Pleasant Grove Baptist Church, and about two (2) miles from the City of Greer, in Chick Springs Township of Greenville County, State of South Carolina, and being Lot No. 28 of the J.M. Mattox Estate according to survey and plat by H.S. Brockman, Surveyor, dated November 6, 1952, and amended February 25, 1956, and recorded in Plat Book JJ, page 127, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on said road, corner of Lots Nos. 26 and 28, and running thence along said road, S. 48-40 W. 100 feet to an iron pin, corner of Lot No. 30; thence S. 41-20 E. 200 feet to an iron pin, rear corner of Lot No. 29; thence along Lot No. 29, N. 48-40 E. 100 feet to the corner of Lot No. 26; thence along the line of Lot No. 26, N. 41-20 W. 200 feet to the beginning corner.
