That W. T. PATRICK and WILLIAM R. TIMMONS, JR., in the State aforesaid, in consideration of the sum of ONE THOUSAND TWO HUNDRED FIFTY AND NO/100----- DOLLARS, (\$1,250.00) to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. P. MEDLOCK, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, and being known and designated as Lot 12 of a subdivision known as Hutton Court, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book NN at Page 101, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Pearce Avenue (formerly Eisenhower Avenue) at the joint front corner of Lots 12 and 13 and running thence N 16-21 W 150 feet to a point at the joint rear corner of Lots 12 and 13; thence S 73-39 W 96 feet to a point on the Eastern side of Hutton Court at the joint corner of Lots 11 and 12; thence with the Eastern side of Hutton Court S 16-21 E 135 feet to a point; thence following the curvature of the Northeastern intersection of Hutton Court with Pearce Avenue (the chord of which is S 61-21 E 21.2 feet) to a point; thence with the Northern side of Pearce Avenue N 73-39 E 81 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

GRANTEE to pay 1957 taxes.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and His Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
