All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County & State aforesaid, on the Northern side of Crane Ave. designated as Lot # 17, Block "B" of Hughes Heights Subdivision, as shown on a plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book "GG" at pages 122-123, and having according thereto the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Crane Avenue at the joint corner of Lots # 17 and #18, and running thence along the line of said lots N. 33-30 E. 172.5 feet to an iron pin; thence along the rear of Lot # 17, N. 58-24 W. 75.04 feet to an iron pin; thence along the line of Lot # 16, S. 33-30 W. 170 feet to an iron pin on Crane Avenue; thence along Crane Avenue S. 56-30 E. 75 feet to the point of BEGINNING.

The above described property is subject to restrictions applicable to Hughes Heights Subdivision, recorded in the R.M.C. Office for Greenville County in Deed Book 526 at page 462.
