All those certain streets or roadways in Bates Township, Greenville County, South Carolina, lying Southwest of S. C. Highway No. 415 and Northwest of Belvue Road, shown on a plat made by Terry T. Dill in August, 1956, said roadway being 50 feet in width and comprising Boswell Drive from the Northwestern intersection with Belvue Road in a North and Easterly direction and also Locust Avenue running from Boswell Drive, Southwesterly to Belvue Road.

This is a portion of property originally conveyed to the grantor as Ollie N. Boswell and this conveyance is made for street and roadway purposes and for inclusion in the County roadway system.
