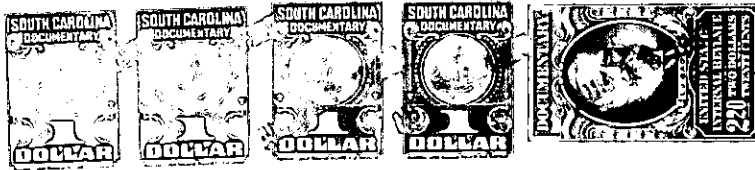

Costner, his heirs and assigns forever,

All that piece, parcel and lot of land in Gantt Township, Greenville County, State of South Carolina, near the City of Greenville, being known as Lot No. 322 according to a survey of Belle Meade Subdivision(Section 3) made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "GG" at Page 187. Said lot fronts on Pine Creek Drive and is more particularly described as follows:

BEGINNING at an iron pin on the east side of Pine Creek Drive at the joint front corner of Lots 321 and 322 and running along Pine Creek Drive N. 32-08 E. 81 feet to an iron pin, joint front corner of Lots 322 and 323; thence along the line of Lot 323 S. 57-52 E. 130 feet to an iron pin, joint rear corner of Lots 322 and 323; thence S. 32-08 W. 81 feet to an iron pin, joint rear corner of Lots 321 and 322; thence along the line of Lot 321 N. 57-52 W. 130 feet to an iron pin on Pine Creek Drive, the beginning corner.

Subject, however, to those protective covenants and restrictions and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 552, at Page 473.

The grantee is to pay 1957 taxes.
