ALL that lot of land in Greenville County, South Carolina known and designated as Lot #16 of Grand-View as shown by a plat made by Woodward Engineering Company, March, 1957, and recorded in the Greenville County R. M. C. Office in Plat Book "KK" at page 93, and having, according to said plat, the following metes and bounds:

BEGINNING at a pin on the northern side of Jasmine Drive (formerly Douglas Street) at the corner of Lot #15 and running thence with the northern side of Jasmine Drive, N. 72-35 E., 63.8 feet to a pin at property now or formerly owned by Allison; thence with lines of Allison and Nesbitt, N. 9-20 W., 151 feet to a pin in the rear corner of Lot #17; thence with the rear lines of Lots #17 and #18, S. 72-35 W., 85 feet to a pin at the corner of Lot #15; thence with the line of Lot #15, S. 17-25 E., 150 feet to the beginning corner.
