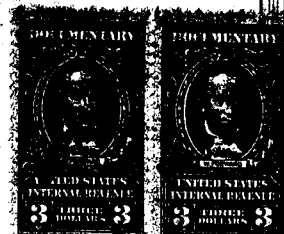

KNOW ALL MEN BY THESE PRESENTS, That I, M. H. Campbell

in the State aforesaid, in consideration of the sum of Six Thousand and no/100 Dollars

to me in hand paid at and before the sealing of these presents by June Young

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said June Young and his heirs and assigns forever

all that piece, parcel or lot of land in Highland Township, Greenville County, State of South Carolina being on the west side of the Old Greenville-

Gowensville Road and bounded on the south by land of D. B. Odom and on the east by land of W. C. Barnett, on the north by lands of E. T. Barnett, J. E. Flynn and John L. Flynn, and by Mrs Smiley Sloan, and on the west by land of C. O. Atkins and W. ... Barnett and contains Thirty-six and 3/10 Acres, more or less, and having the following Metes and Bounds:

Beginning at a Pine Knot and Iron pin, corner of Odom's land and the lower described 9.27 Acres tract and land of Mrs W.W. Barnett and running thence N. 84-57 E. 1627 feet to point in Old Greenville Road; thence along road N.1-00 E. 715 feet to a nail and cap in road; thence N. 25-00 E. 204.6 feet to a nail and cap in road; thence N. 48-00 E. 139.8 feet to nail in road; thence N. 4-00 E. 65 feet to a nail and cap in a Greenville County Road that leads towards Pleasant Hill Church; thence S. 73-50 W. 2416.5 feet to iron pin on C.O. Atkins line also corner of Mrs Smiley Sloan land; thence S. 39-15 E. 722 feet to beginning corner.

Also a line and 27/100 Acres, more or less, bounded by lands of D.B. Odom and Mrs Pearle Henson, Mrs Belle Howard and Mrs W.W. Barnett with Metes and Bounds as follows:

Beginning at the same Pine Knot and Iron Pin as above tract and running thence S. 32-00 W. 488 feet to a Stone and Iron Pin, corner of Belle Howard land; thence S. 36-30 E. 838 feet to an iron bar corner on Mrs Pearle Henson's land line; thence N. 46-55 E. 448.8 feet to a Stone corner on D.B. Odom line; thence N. 36-00 W. 961 feet to beginning corner and Containing Nine and 27/100 Acres of land more or less, being the same tract of land conveyed by Thomas Babb to, C.B. Jackson, dated November 2, 1906.
