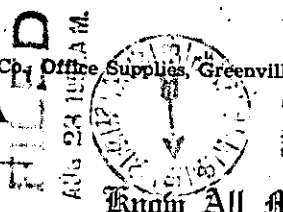

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Caroline D. Rogers, her heirs and assigns forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 132 on a Plat of Section No. 2 Caroline Court, dated November 1953 by Dalton & Neves, recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 21, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Manchester Avenue at joint front corners of Lots 131 and 132 and running thence along the line of said lots, N. 25-15 E. 240 feet to iron pin; thence running, S. 64-45 E. 100 feet to iron pin at rear corner of Lot 133; thence running with line of said lot, S. 25-15 W. 240 feet to iron pin on Manchester Avenue; thence running with said Avenue, N. 64-45 W. 100 feet to iron pin at point of beginning.
