Burger in the State aforesaid, in consideration of the sum of SIX HUNDRED AND TWENTY-FIVE and no/100 (\$625.00)--- DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JAMES E. BURGER, his heirs and assigns forever:

All that lot of land in Greenville County, South Carolina on the northern side of Crestmore Drive, known as Lot #37 of Grand View, as shown by a plat thereof made by Woodward Engineering Company, March, 1957, and recorded in the Greenville County R. M. C. Office in Plat Book "KK", at page 93, and having, according to said plat, the following metes and bounds:

BEGINNING at a pin on the northern side of Crestmore Drive at the corner of Lot #36, and running thence with the northern side of Crestmore Drive N. 74-17 E., 64 feet to a pin at the corner of Lot #38; thence with the line of Lot #38, N. 15-43 W., 160 feet to a pin on the subdivision property line; thence with the subdivision property line, S. 74-17 W., 64 feet to a pin at the rear corner of Lot #36; thence with the line of Lot #36, S. 15-43 E., 160 feet to the beginning corner.

This is the same property conveyed to me by Arrowood and Burger by deed recorded in Vol. 573 at page 314, and to them by Eliza T. Loper by deed recorded in Vol. 573 at page 311.

This lot is subject to restrictions recorded in Vol. 573 at page 415 and in Vol. 574 at page 93.

The grantee owns a one-half beneficial interest in this land, and the expressed consideration is for the remaining one-half interest.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
