Know All Men by These Presents:

That I, M. W. Fore in the State aforesaid, in consideration of the sum of Five Hundred Forty Five & NO/100 (\$545.00) - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. T. Tucker and Minnie L. Tucker, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 69 of a subdivision known as Section "B" of Englewood Estates, as shown by a Plat thereof, dated November, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, BB, at Page 11, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Buffalo Drive at joint front corners of Lots No. 69 and 70 and running thence along the line of said lot No. 70, S. 87-30 E. 448.7 feet to iron pin; thence N. 3-02 E. 60 feet to iron pin at back corner of Lot No. 68; thence along the line of said Lot No. 68, N. 87-30 W. 449.5 feet to iron pin on Buffalo Drive; thence running with the said Buffalo Drive, S. 2-30 W. 60 feet to iron pin at point of beginning.

THIS deed is made subject to the following restrictions:

1. No house is to be erected costing less than Five Thousand (\$5,000.00) Dollars.
2. No house to to be built closer than fifty (50) feet to the street.
3. No temporary house is to be erected on said lot.

THIS deed is made subject to all easements and rights of way of record.

GRANTEE to pay taxes for the year 1957.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

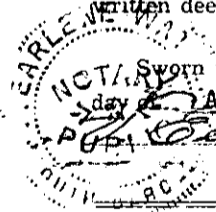

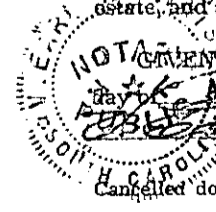
