KNOW ALL MEN BY THESE PRESENTS, That Frank Jones, R. A. Manley and J. N. Seawright, as Trustees of the Church of God (Piedmont, S.C.) Over Which M. A. Tomlinson Is General Overseer, One (\$1.00), and in order to evidence in the State aforesaid, in consideration of the sum of _____ Dollars, the change in name of said church- _____ to us _____ in hand paid at and before the sealing of these presents by Frank Jones, R. A. Manley and J. N. Seawright, as Trustees of the Church of God of Prophecy, in Piedmont, S. C., (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Frank Jones, R. A. Manley and J. N. Seawright, as Trustees of the Church of God of Prophecy, in Piedmont, S.C.:

- (1) All that piece, parcel or lot of land consisting of 5.73 acres, more or less, situate, lying and being in or near the Town of Piedmont, County of Greenville, State of South Carolina, as shown on a plat thereof entitled "Property of Piedmont Mfg. Co." made by Dalton & Neves, December, 1950, and recorded in the R.M.C. Office for Greenville County in Plat Book Z, at page 157, and being the identical property conveyed to the Trustees of said church by J. P. Stevens & Co., Inc., by its deed dated February 21, 1951 and recorded in the R.M.C. Office for Greenville County in Deed Book 429 at Page 545.
- (2) All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, containing 7/10th of an acre, more or less, and being more particularly described according to plat of survey of J. Coke Smith and Son, dated May 11, 1949, and being the identical property conveyed to the Trustees of said church by J. O. Lindley by his deed dated May 11, 1949, and recorded in the R.M.C. Office for Greenville County in Deed Book 422 at Page 183.
- (3) All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, containing 2/10th of an acre, more or less, and being more particularly described according to plat of survey of J. Coke Smith and Son, dated May 11, 1949, and being the identical property conveyed to the Trustees of said church by J. T. Lindley by his deed dated May 11, 1949, and recorded in the R.M.C. Office for Greenville County in Deed Book 422 at Page 165.

This conveyance is made pursuant to the direction and authority of the congregation of said church for the sole purpose of evidencing the change in the name thereof, and subject to any and all easements, rights of way, reversions, or rights thereto affecting the within described property.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the Premises before mentioned unto the said Frank Jones, R.A. Manley and J.N. Seawright, as Trustees of the Church of God of Prophecy, in Piedmont, S.C., their successors, successors in office, and ~~He~~ and Assigns forever, subject, however, to any and all easements, rights of way, reversions of rights thereto affecting the within described property.
