ALL that lot of land in Greenville County, South Carolina on the southern side of Crestmore Drive known and designated as Lot #30 of Grand-View, as shown by a plat thereof made by Woodward Engineering Company, March, 1957, and recorded in the Greenville County R. M. C. Office in Plat Book "KK" at page 93, and having according to said plat, the following metes and bounds:

BEGINNING at a pin on the southern side of Crestmore Drive at the corner of Lot #31 and running thence with the southern side of Crestmore Drive, N. 74-17 E., 60 feet to a pin at the corner of Lot #29; thence with the line of Lot #29, S. 15-43 E., 168.6 feet to a pin in the rear line of Lot #4; thence with rear lines of Lots #4 and #3, S. 72-35 W., 60.02 feet to a pin at the corner of Lot #31; thence with the line of Lot #31, N. 15-43 W., 170.4 feet to the point of beginning.
