G. PROFFITT, his heirs and assigns,

All that certain piece, parcel or lot of land situate, lying and being on the Easterly side of South Warwick Road, in Paris Mountain Township, near the City of Greenville, in Greenville County, state of South Carolina, being known and designated as Lot No. 79 of a subdivision known as Stratford Forest and having according to a plat of said subdivision prepared by Piedmont Engineering Service, dated February 25, 1957, and recorded in the RMC Office for Greenville, S. C. in Plat Book KK at page 89, the following metes and bounds:

Beginning at an iron pin on the easterly side of South Warwick Road, at the joint front corner of Lots Nos. 78 and 79, and running thence with the line of Lot No. 79, S. 81-47 E. 245.2 feet to an iron pin; thence with the rear line of Lot No. 71, S. 28-11 W. 240.5 feet to an iron pin at the joint rear corner of Lots Nos. 79 and 80; thence with the line of Lot No. 80, N. 58-55 W. 199.2 feet to an iron pin on the easterly side of South Warwick Road; thence with the easterly side of South Warwick Road N. 15-55 E. 150 feet to the point of beginning.

This is the same property conveyed to grantor by The Peoples National Bank of Greenville, S. C., as Agent for Furman University dated September 17, 1957 and recorded on this date, and is conveyed subject to restrictions recorded in deed book 578 page 1, and to drainage and utility easements, if any, affecting this property as shown on the aforesaid plat.
